

Rivian Project Planning Committee Overview

On March 14, 2022, the Georgia Department of Economic Development (GDEcD) announced the makeup of the four committees being established to ensure public input into a variety of factors involved in the planning stages of the carbon-conscious campus for the 7,500-job Rivian project at Stanton Springs North. Local and state committee members represent a wide cross-section of all four Joint Development Authority (JDA) counties, and volunteered or agreed to serve in this capacity. Meetings are being planned for each of the committees within the Jasper, Morgan, Newton, and Walton county area for ease of planning and public input. Each committee will have a designated official staff coordinator and assistants, along with a representative from Rivian participating. At the conclusion of committee meetings, recommendations will be developed by the committees and reported to the State of Georgia and Rivian.

This committee approach will ensure direct coordination of considerations from across multiple jurisdictions and land parcels, and the public feedback process will allow all communities to have a voice across the decision-making process. The state has committed to continuously work with city and county governments to ensure that every concern is heard, and every question is answered.

1. Workforce Development

Mission Statement: To meet current and future workforce needs for Rivian and other existing industries as well as for future prospects within the region. To effectively plan for future workforce growth and demand and address key issues like wages, in-demand careers, and industry trends with input from the private sector. To coordinate with K-12 systems, the University System of Georgia, and the Technical College System of Georgia to identify necessary training programs are in place and a sufficient pipeline of future workers will exist to meet industry needs.
