

Government and Commerce

Peru has maintained a consular presence in Georgia since 1995, when the Honorary Consulate opened, to be followed by the 2006 opening of the Consulate General. The office has jurisdiction over six southeastern U.S. states. Mr. Jaime Sparks has served as Consul General since August 2019.

The State of Georgia has had representation in Peru since 2018. Ximena Portillo serves as the state's representative in the market.

The Peruvian-American Business Chamber of Georgia, a division of the Georgia Hispanic Chamber of Commerce, promotes business, tourism and investment between Peru and the United States.

The Georgia Hispanic Chamber of Commerce was founded in Atlanta in 1984 and promotes the domestic and international economic development of Hispanic businesses and business people. The organization seeks to bring the issues and concerns of the growing number of Hispanic entrepreneurs to the forefront of Georgia's economic agenda.

The fourth annual Americas Competitiveness Forum (ACF) was held in Atlanta in November 2010, marking the second time Atlanta hosted the ACF. The purpose of the forum is to provide an opportunity for governments, business community and representatives from academia and non-governmental organizations to discuss actions that can be taken to improve competitiveness and economic prosperity in the Americas.

During his time in Congress, former Governor Nathan Deal voted in favor of an agreement between the United States and Peru to promote free trade in 2008.

Decatur, Georgia has a sister city agreement with Trujillo, Peru.

Academics

In the Fall semester of 2022, 174 Peruvian students will be enrolled in USG schools.

The COVID-19 pandemic affected study abroad programs around the world, but these programs are expected to return to former participation levels soon. In previous years, the University System of Georgia (USG) offered 21 study abroad programs to Peru in programs such as language, psychology, nursing and international business.

Emory University also provides programs for students to study abroad in Peru.

Arts and Culture

Founded in Atlanta in 2008 by Peruvian native John Zorilla, the organization Apu Inka records and promotes Latin American folk music and traditions and performs concerts around the world.

In December, 2017, the Michael C. Carlos Museum hosted the exhibit, Threads, which focused on the history of textiles in Central and South America, including Peruvian textiles.

Eva Ayllón, one of Peru's most enduring stars, performed in 2018 at the Rialto Center for the Arts in Atlanta.

International Trade

The United States- Peru Trade Promotion Agreement (PTPA), a comprehensive bilateral free trade agreement, took effect on February 1, 2009.

EXPORTS: In 2021, Georgia exports to Peru totaled **\$152.5 million**. Peru is the **46th** largest export market for Georgia.

Top exports from Georgia to Peru include cotton, poultry, insecticides, kraft paper and paperboard, and acrylic polymers.

Georgia leads the nation in the export of the following goods to Peru: insecticides, kraft paper, and poultry.

IMPORTS: In 2021, Georgia imports from Peru totaled **\$202.6 million**. Peru ranks **46th** among Georgia's importer nations.

Top imports from Peru to Georgia include onions, grapes, strawberries, avocados, and sugar.

Transportation

Hartsfield-Jackson Atlanta International Airport offers daily nonstop flights from Atlanta to Lima, Peru. In 2022, there will be an estimated 365 flights between Peru and Georgia carrying over 82,000 passengers.

International connectivity has been limited by the COVID-19 pandemic. As restrictions ease, the Hartsfield-Jackson Atlanta International Airport expects a return to pre-COVID connections.

The Georgia Ports Authority (GPA) in Brunswick has an established relationship with the ports of Peru and offers shipping services to Callao.
