Chairman Neely called on Commissioner Pat Wilson to present the Commissioner's Report.

It's great to be in a thriving community like Gainesville. I want to thank Chairman Ron Stephens on the Economic Development and Tourism Committee for being here.

Your Board Book in front of you covers Q4 of the fiscal year: that's April through June. I'll cover this timeframe and more. So please do refer to your book for a more complete picture of news and upcoming events – take it home. Let us know if you have questions.

#### **Council for the Arts**

- Tina provided a great example already today of the ways that Georgia Council for the Arts works with our communities.
- And Governor Deal was responsible for bringing Georgia Council for the Arts under the GDEcD umbrella back in 2011!
- We always say that economic development doesn't happen in a vacuum.
- We're still seeing the benefits of being one team with Tourism, Film, Trade, Global Commerce –
  and more as we work every day to remain connected and break down silos to pursue
  opportunity.

#### Here in Gainesville:

- Seven artists have work in the current round of "Art of Georgia" exhibit at the State Capitol & Governor's Mansion, where the artworks will hang for a year.
- Elachee Nature Science Center earned an FY23 Arts Education grant (\$5K)

In the coming weeks, GCA will release our new strategic plan. There is a new focus on creative placemaking programs for rural communities as well as arts education.

#### **Center of Innovation**

- We've recently further strengthened our AgTech team adding a food safety specialist to the team to work with the small and medium-sized food processors across the state. Justin Edwards is a former USDA food inspector and can help these businesses more effectively navigate the regulatory issues around their food business.
- We hosted the 2nd annual AgTech Summit in June at Middle Georgia State University in Macon.
- This year's Summit brought together industry, academia, and government partners in the AgTech ecosystem. Presenters ranged from Fortune 500 companies such as AGCO to Georgia-based small businesses such as PermaTherm and nonprofits such as the Georgia Foundation for Agriculture and the Conservation Fund.
- The Center of Innovation hosted the first-ever Georgia AgTech Startup Pitch Competition.
- We have a new blog on the website with more information about this event, or you can talk with Center of Innovation Director David Nuckolls.

#### Film Office

Of course, we are celebrating 50 years of Georgia film! Instead of a big report here, I'm going to talk about what the impact of this industry brings to Hall County.

- Over 60 studio productions are in Hall County's filmography, and the community is on the radar
  of major studios who bring their productions and dollars with them.
- The Netflix series "Ozark" filmed here for all four of its seasons.
  - The production was a very good business partner and their hard work has left behind some small business opportunities.
  - First, the production kept a year-round base camp at one of the local dormant Corps of Engineers parks this resulted in:
    - Year-round rent and utilities being paid from an asset that had been closed for over 10 years.
  - Park locations were also used on-screen.

A couple of fun examples of economic impact include:

- The Byrd House the residence of the main characters now serves as a very exclusive vacation rental, going for more than \$1,800 a night.
  - The homeowners who worked with Ozark throughout the production penned a deal with them to leave behind all the furnishing and décor from the set.
- Ozark location tours by boat:
  - One of Lake Lanier's local fishing and party boat charter captains began offering Ozark tours on one of his vessels. During shoots, tours were going for over \$300 per person due to high demand and limited space.
  - He now offers a post-production tour that takes guests to the locations and they are shows photography and film clips from the show to complete the experience.
  - Marinas & Restaurants:
    - Several shoreline businesses, including marinas and restaurants, were also featured in Ozark. One in particular was used several times as a local watering hole for characters on the show. This restaurant offers Ozark themed drinks and fans can snap photos where the cast filmed their scenes.
    - Another restaurant was featured in the final season of the show and they have seen an uptick in visitors dining there as part of their Ozark touring experience.

#### **Global Commerce**

Kristi Brigman gave the main update and deep dive for you here. I have to say thanks to this entire team – including our Board – for the results and opportunities we've been able to realize over these last several years. It's an incredible time to be in economic development!

Years of work has brought us to this point, and it's on us to continue to plan for the future, be responsive to business, and deliver results.

We've re-organized the Global Commerce team a bit to help maximize this moment and carry the load...

#### **International Trade & International Relations**

I want to thank our International Relations team of Nico Wijnberg and Coryn Marsik for their work. You saw the FDI results, and these folks and our International offices play a big role in this growth. Their work cuts across divisions to ensure our long-term global partnerships are steady, and growing.

This past summer, they led Governor Kemp's missions to Israel, the Paris Air Show, and the Country of Georgia. Governor Kemp was the first sitting U.S. Governor to visit the country, where we have a special relationship through the Georgia Guard.

Nico is also the Chief Protocol Officer for the State of Georgia. In addition to serving as the primary lead on our international missions, International Relations also coordinates visiting international delegations and dignitaries, maintains ties with bi-national chambers of commerce, the Georgia-based Consular Corps, and much more. They are an integral part of our team, so they have moved under the Commissioner's Office umbrella at our Department.

#### Tourism/Explore Georgia

In June, Explore Georgia led a statewide exhibition at the leading international travel trade show. The Explore Georgia "campus" featured 4 destinations:

- Atlanta
- Ellijay
- the Golden Isles, and
- Savannah,
- As well as 2 private-sector partners: the Atlanta Braves and Okefenokee Swamp.

By presenting tourism product from across the state, Explore Georgia drove more foot traffic and awareness among the 5,000 international travel buyers and media than any single destination could have accomplished on its own.

I want to thank you all for serving our state through our Board. We've had a few opportunities to see Board members at State events, and the ways you're representing the work of our Department and making connections in your regions of the state. We love seeing that activity and hearing from you often!

Chairman Neely reminded board members to call on the Department for presentations and take what they hear back to their communities. He said the role of a board member is communication — we have influence in our role. Be a liaison in two ways: take home resources and bring back information of what's going on in our communities to the Department.

He adjourned the meeting at 4:30 pm.

#### RESOLUTION

WHEREAS, the Board of Economic Development ("GDEcD Board") is charged with the direction, supervision and policy setting for the Department of Economic Development ("GDEcD") of the State of Georgia, and pursuant to O.C.G.A. § 50-7-16, GDEcD with the approval of the State Properties Commission (the "Commission"), has the power to convey real property;

WHEREAS, the Commission, is the fee simple owner of certain land held in GDEcD's custody (the "Site"), with such land being located in Walton County and identified at Exhibit "A";

WHEREAS, such Site is to be used to develop, construct and operate a Technical College of Georgia QuickStart Training Center (the "Training Center") for the benefit of Rivian Horizon, LLC ("Rivian");

WHEREAS, GDEcD, through the State Properties Commission, seeks to transfer custody of the Site from GDEcD to the Technical College System of Georgia to develop, construct and operate the Training Center;

WHEREAS, GDEcD supports authorizing this conveyance to allow the Commission to transfer custody of the Site to the Technical College System of Georgia; and

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE BOARD OF THE ECONOMIC DEVELOPMENT request that the State Properties Commission authorize the transfer of custody of the Site from GDEcD to the Technical College System of Georgia, subject to approval by the State Properties Commission;

AND BE IT FURTHER RESOLVED that the Chairman is hereby authorized to do all things necessary and proper to implement the purpose of this resolution.



WHEREAS, pursuant to O.C.G.A. § 50-16-42, the Commission has the authority to grant a revocable license agreement or easement for property under the custody and control of any state agency; and

WHEREAS, EMC, through the State Properties Commission, requires GDEcD to authorize a revocable license agreement, and any subsequent temporary or permanent easement, as required or approved by the Commission, to EMC so that EMC can install the Project as identified on Exhibit "A"; and

WHEREAS, the Department supports authorizing this resolution so as to allow the Commission to grant the revocable license agreement, and any subsequent temporary or permanent easement, as required or approved by the Commission, to EMC as shown in Exhibit "A"; and

NOW, THEREFORE, BE IT HEREBY RESOLVED THAT THE BOARD OF THE ECONOMIC DEVELOPMENT request that the State Properties Commission authorize the granting of the revocable license agreement, and any subsequent temporary or permanent easement, as required or approved by the Commission, on the Property as shown in Exhibit "A";
